#### BYLAW CHEATSHEET

vii.G.

No more than \$15.00 shall be allocated per Muir College student per event to help pay for the cost of attending conferences, seminars, workshops, competitions, off-campus community service, and other activities of this nature. Funding requests that fall under this category are not subject to the \$75 funding cap from non-Muir organizations (see Bylaw VIII. L.)

vii. H.

Funding requests must be presented to Council at least one week prior to the event, with a written line-item (itemized) budget that indicates anticipated and secured expenditures and resources.

a) Liens should be released prior to the date of the event.

vii. L.

Any individual allocation to a non-Muir organization, activity, or event shall not exceed \$75.
